### Critical Success Factors:

1. Construct a gender mainstreaming policy plan.
2. Identify an initiator/leader who is the person who will be responsible for carrying forward gender mainstreaming.
3. Design a plan that takes the actual situation into account. The final step is to monitor the results.
4. Conduct regular consultation sessions with staff and customers in order to assess the effects of such policy. This is necessary to build on this learning curve and strengthen its potential.
5. Provide induction training to new recruits in order to make them aware of the work processes, policies and activities within the business organization.

Policy initiatives require follow-up, thus monitoring is necessary to serve this purpose. The manner in which monitoring is to take place has to be decided when the gender mainstreaming project is initiated. During this stage the techniques, tools and criteria for monitoring policies need to be defined.
